

1ST ANNUAL POKER PADDLE ON BEAUTIFUL LAKE ALMANOR, CA JULY 29, 2017 STARTING AT 9:00 AM

Paddlers (kayak, canoe, SUP)

This is a five-card poker run on the water from Canyon Dam Boat Launch to Plumas Pines Resort along the west shore of the 8th largest reservoir in California. It's 10 miles roundtrip!



So what's a Poker Run?

Paddlers will make 5 shore stops at 3 different locations to pick up 5 poker cards, which make up the poker hand. First and second place prizes awarded to the paddlers with the best poker hand.

Bring your own non-motorized vessel (NMV) and safety equipment to the starting/finish line at the Canyon Dam Boat Launch. Equipment is also available for rent in our area.

Why travel to Lake Almanor? Lake Almanor is a stunningly beautiful lake in the Sierra/Cascade Mountains, with a maximum surface elevation of about 4500 feet. The surface water temperatures can reach 65 to 70 + degrees. The west shore of Lake Almanor has great campgrounds, RV parks, cabins and associated resort restaurants, cafes, bars and swimming areas.

What's the Deal? Single paddlers with non-motorized vessel: \$65; First 30 paddlers before 5/31/17 with non-motorized vessel: \$60; Second Paddler in same *NMV: \$30. All paid paddlers will receive a box lunch, power bar, water map and a hat. All paddlers must have an approved PFD on the water.
